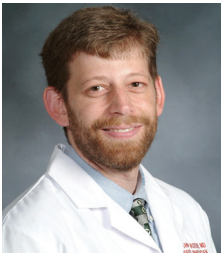

Transforming The Emergency Response for Elder Abuse Victims



DR. TONY ROSEN

Dr. Tony Rosen is the founder and lead investigator of the Vulnerable Elder Protection Team (VEPT) at the New York-Presbyterian Hospital/Weill Cornell Medical Center. The VEPT program is an emergency department-based, multi-disciplinary approach to responding to potential elder abuse or neglect with a goal of increasing identification and enhancing safety of older adults.

Alyssa is a social worker and program administrator for the VEPT. She contributed to the development of this program and coordinates the everyday operations of the VEPT. Alyssa also contributes to research pertaining to elder abuse and the VEPT.

Transforming the Emergency Response for Elder Abuse Victims: Part 2

Potential risks to individuals and the community from the use of motor vehicles and firearms by those with diminished capacity will be identified. Voluntary strategies for long-term safety planning will be introduced, with the goals of preserving an individual's wishes in the event that s/he is unable to express them in the future and reducing the possibility of unsafe use of a motor vehicle or firearm. Participant response and discussion will be invited.

New York State is the only state that does not mandate reporting of Elder Abuse. These are challenges for all professionals when deciding the next step. Hesitancy to act can be rooted in "Am I doing the right thing?", "Is what is happening really happening?", "What if I am wrong?" Presenters will guide participants with an ethical analysis of what to do when the path is not clear. The interaction between Adult Protective Services and the medical and financial fields will be discussed.

Collaborative Approach: The Impact of Forensic Accounting on Cases of Financial Exploitation

Cultural Competency: Things you need to know when working with the Refugee and Immigrant community

With over 10,000 refugees in the Syracuse area, it is critical for service providers to learn more about their experiences to better meet their needs. Hear how one local program (RISE) works with refugees in our community. Presenters will provide a more in depth review of the Somali and Bhutanese cultures and will share their thoughts on how elder abuse may present itself in those communities.

Depression Among Elder Abuse Victims: Screening and Treatment

Presenter: Jo Anne Sirey, Ph.D, Weill Cornell Institute of Geriatric Psychiatry

In this workshop we will review the implementation of screening for depression (PHQ-9) among elder abuse victims and the integration of a brief treatment for depression (PROTECT). Data will be presented on rates of depression using the screening tool in New York City. We will also briefly describe the brief therapy being offered to support depressed victims and its impact.
