When you call our 24-hour crisis & support line, you will reach a trained counselor who will listen and offer support as you decide what to do next.

If you are in a dangerous situation, we will help you make a plan to keep you & your family safe.

We can help you apply for crime victims compensation if you were physically injured or are under 18, 60 and over, or disabled.

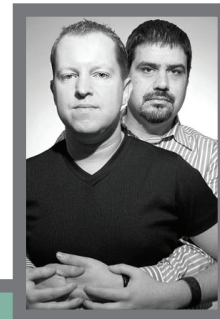
